

**CITY OF BELLEMEADE, KY**  
**ORDINANCE # 2020-01**

**AN ORDINANCE OF THE CITY OF BELLEMEADE, KENTUCKY ENACTING AND ADOPTING A CODE OF ORDINANCES OF THE CITY OF BELLEMEADE, KENTUCKY.**

**WHEREAS**, it is in the best interests of the City of Bellemeade and the Commission of the City of Bellemeade to have a well-documented and readable set of ordinances

**WHEREAS**, ordinances are easier to reference by code number and line than by ordinance number and date of enactment

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BELLEMEADE**

**Section 1.** The code of ordinances submitted and read by the Bellemeade Commission on 1/13/2019 (herein referred to as the "Code") is hereby adopted and enacted by reference as set out in its entirety and is hereby designated as the "Code of the City of Bellemeade, Kentucky."

**Section 2.** At least one copy of the Code is filed in an "Ordinance Book" and kept by the City Clerk and shall remain with the clerk for use and examination by the Public.

**Section 3.** A digital copy of the Code shall be kept by the City Clerk and shall be distributed on written request by the Public, within a reasonable period of time.

**Section 4.** The City Commission shall be responsible for updating the Code and providing those updates to the City Clerk for keeping.

**Section 5.** All ordinances, excluding budget and tax ordinances, passed before adoption of this ordinance and not included in the Code are hereby repealed.

**Section 6.** The provisions of the Code, insofar as they are substantively the same as those of ordinances in force immediately prior to the enactment of this ordinance, are intended as a continuation of such ordinances and not as new enactments and the effectiveness of such provisions shall date from the adoption of the prior ordinance not from the adoption of the Code. All provisions are hereby continued in full force and effect and are hereby reaffirmed as to their adoption by the City Commission of the City of Bellemeade, Kentucky.

**Section 7.** If the Bellemeade City Commission shall desire to amend any existing chapter or section of this Code, the chapter or section shall be specifically repealed and a new chapter or section, containing the desired amendment, substituted in its place.

**Section 8.** Any ordinance which is proposed to add to the existing Code a new chapter or section shall indicate, with reference to the arrangement of this Code, the proper number of such chapter or section. In addition to such indication thereof as may appear in the text of the proposed ordinance, a caption or title shall be shown in concise form above the ordinance.

**Section 9.** Said Code shall be in full force and effect upon receipt by the City Clerk from the Commission, and said Code shall be presumptive evidence in all courts and places of the ordinance and all provisions, sections, penalties and regulations therein contained and of the date of passage, and that

the same is properly signed, attested, recorded and approved and that any notice thereof as required by law have been given.

**Section 10.** This ordinance shall take effect from and after passage by the City Commissioners and publication as required by law.
