Call to Order - Mayor James Martin called the meeting to order at 7:06 pm at the Steel Technologies Building, The 700 Room, 1st Floor 700 North Hurstbourne Parkway, Louisville, KY 40222. Mayor Miller asked if there were any additions to the Agenda at this time. Robin Mountain wished to add a Public Works Report. Reports - Treasurer's Report - Geri Huff presented the Treasurer's Report. Expenses were as expected for the month of July. As discussed in the last meeting, the Insurance and IT budgets have been updated to accommodate expenses, with funds being applied from the Miscellaneous category.

Expenses for N. Chadwick repaying were sent in to receive the grant funds. Geri informed the commission that we had received a check for \$19,000- substantially less than the originally expected amount. This is presumably due to the actual cost coming in much lower than the quoted amount. She has not deposited the check and will follow up with Metro regarding the final grant amount.

TOP CARRY TO THE PERSON SUBSTICION James Martin moved to approve the Treasurer's Report as presented, second by Halle Brumleve, and the Treasurer's report passed unanimously as presented.

Mayor's Report - James Martin discussed the issue of short term rentals in Bellemeade as this has been brought to both his and Commissioner Osborne's attention. Robin Mountain commented that guidelines would be useful to address this issue. Ed Osborne informed that there are no guidelines at this point.

Mayor Martin informed the Commission that the following individuals have applied for write-in status for Commissioner positions in the upcoming election:

The deadline to apply to be a write-in candidate is October 23, 2020.

Mayor Martin will hold a web training session for new commissioners and others who are interested. The meeting will be conducted via Zoom on Monday 9/21 at 7pm..

Public Works Report – Commissioner Robin Mountain reported that the sinkhole on Dorchester has been covered with sheet metal at this time as work will continue to repair it.

A citizen has inquired whether we can get new signs for the speed humps. Mayor Martin suggested that this could be part of Milestone's proposal. Commissioner Mountain will follow up with Mark Madison at Milestone to add signage to their evaluation. Robin Mountain also informed the commission that he had identified a number of lights and signs that seemed damaged or tilting. He will follow up with the appropriate company to have them looked at. A few of them had resolved once the rain stopped, suggesting they are not in stable soil.

Public Safety Report - Another citizen suggestion has been made to install cameras and signage at all Bellemeade entrances to deter car and home break-ins. After discussing the cost of such a project and the already tight public safety budget, it was decided that funds would be better spent on adding patrols to our schedule. There was further discussion about better control and evaluation of the existing patrols. Ed Osborne will request a list of patrols and shifts for the upcoming month from Kentuckiana Law Enforcement to make sure we are being properly covered.

Bob Elliott informed the Commission of a stop sign on Charing Cross that is obscured by tree branches. Ed Osborne will follow up on this with the homeowner.

Ed Osborne commented that many state roads use a white painted stripe at stop signs to further inform drivers that there is a stop there. He will look into this, and it was suggested that Milestone can include this in their assessment.
